Emergency Regulation to Protect Outdoor Workers from Wildfire Smoke in Effect

Cal/OSHA's emergency regulation requiring employers to protect workers from hazards associated with wildfire smoke is now in effect, following its approval yesterday by the Office of Administrative Law. Under the new emergency regulation, employers must take the following steps to protect workers who may be exposed to wildfire smoke:

- Identify harmful exposure to airborne particulate matter from wildfire smoke at the start of each shift and periodically thereafter by checking the AQI for PM 2.5 in regions where workers are located.
- Reduce harmful exposure to wildfire smoke if feasible, for example, by relocating work to an
 enclosed building with filtered air or to an outdoor location where the AQI for PM 2.5 is 150
 or lower.
- If employers cannot reduce workers' harmful exposure to wildfire smoke so that the AQI for PM 2.5 is 150 or lower, they must provide:
 - o Respirators such as N95 masks to all employees for voluntary use, and
 - Training on the new regulation, the health effects of wildfire smoke, and the safe use and maintenance of respirators.
