# **Did You Know?**

Every year, dozens of workers die and thousands more become ill while working in hot or humid conditions. OSHA's revised Heat Illness Prevention campaign webpage consolidates resources on the dangers of working in the heat and how to keep workers safe.

OSHA launches national emphasis program to Protect Workers from Heat

OSHA is launching a targeted National Emphasis Program (NEP) to protect workers across the nation from the increasing threat of heat-related illness. This NEP is effective as of April 8<sup>th</sup> and will remain in effect for three years unless canceled or extended by a superseding directive.

OSHA's NEP creates, for the first time, a nationwide enforcement mechanism for OSHA to proactively inspect workplaces for heat-related hazards in the general industry, maritime, construction or agricultural operations where hazardous exposures to heat (outdoors and indoors) are a factor. This means that OSHA can now launch heat-related inspections on high-risk worksites before workers suffer preventable injuries, illnesses or fatalities.

### ASSP Foundation awards \$251,000 in Scholarships and Grants

The ASSP Foundation is awarding \$251,000 in scholarships and grants to 133 people to help them achieve educational and career goals in the OSH profession.

"For over 30 years, our Foundation has helped thousands of students and professionals continue their education in workplace safety and health," said ASSP Foundation Chair Trish Ennis, CSP, ARM, CRIS. "The consistent support from donors shows that safety and health careers are vital in helping to protect workers everywhere."

The 2022 awards include more than \$225,000 in academic scholarships for 100 graduate and undergraduate students preparing for or supplementing their occupational safety and health careers at 48 colleges and universities. The ASSP Foundation is awarding more than \$25,000 in career development grants to 33 safety students and professionals who are working to advance their careers through certification, conference attendance and similar learning opportunities. Career development grants will continue to be awarded throughout the year.
